The list of documents necessary for registration of contracts at the State Commodity and Raw Materials Exchange of Turkmenistan

The contract concluded in foreign currency for construction and reconstruction of objects

1. Application Letter to the Commodity Exchange with the request for contract registration.
2. Submission of the contract in not less than four copies (original).
3. The approval document of the President of Turkmenistan.
4. Authorization of the Deputy Chairman of the Cabinet of Ministers of Turkmenistan supervising corresponding industry (under the contracts concluded by legal persons of public sector).
5. The positive conclusion of serving bank.
6. The conclusion of the Ministry of Economics and Development of Turkmenistan.
7. The conclusion of the Ministry of Construction and Architecture of Turkmenistan.
8. Conclusion of the State Commodity and Raw Materials Exchange of Turkmenistan (GTSBT) on the prices for the goods imported into Turkmenistan.
9. Documents confirming the right of realization of an entrepreneurial activity:
 - Legal persons - the Charter or Regulations, the statement from Unified State Register of Legal Entities (EGRUL), the registration certificate, the certificate of the participant of foreign trade activities.
10. Appropriate license for separate kinds of licensed activity.

Note:

1. The Commodity Exchange is entitled to request additional documents according to requirements of the current legislation of Turkmenistan, as well as depending on contract specifications.
2. Contract parties bear responsibility for reliability of documents represented to the Commodity Exchange.

The list of documents necessary for registration of contracts at the State Commodity and Raw Materials Exchange of Turkmenistan

Additional agreement to the contract concluded in foreign currency for construction and reconstruction of objects

1. Application Letter to the Commodity Exchange with the request for additional agreement registration.
2. The letter of higher authority permitting registration of additional agreement (the state enterprises).
3. Additional agreement submitted in not less than four copies.
4. The copy of beforehand registered contract and additional agreements.
5. The conclusion of the Ministry of Economics and Development of Turkmenistan.
6. The positive conclusion of serving bank (at change of the total amount of the contracts concluded by legal persons of public sector, and bank details).
7. Authorization of the Deputy Chairman of the Cabinet of Ministers of Turkmenistan supervising industry (for the state enterprises).
8. Authorization of the Chairman of the Cabinet of Ministers of Turkmenistan in a case of increasing the price of the contract (for the state enterprises).
The conclusion of the Ministry of Construction of Turkmenistan (at change of quantity and the commodity list of the goods),
The conclusion of the State Commodity and Raw Materials Exchange of Turkmenistan (GTSBT) at the prices for the goods imported into Turkmenistan (at change of quantity and the commodity list of the goods).
9. Appropriate license for separate kinds of licensed activity.

2. Contract parties bear responsibility for reliability of documents represented to the Commodity Exchange.
