The list of documents necessary for registration of contracts at the State Commodity and Raw Materials Exchange of Turkmenistan

The contract for commodity exchange (barter)

- 1. Application Letter to the Commodity Exchange with the request for contract registration.
 - 2. The contract is submitted in not less than three copies (original).
- 3. Calculation of cost efficiency of the contract for the commodity exchange confirmed by the head of enterprise.
- 4. The letter of higher authority permitting the conclusion and registration of the contract (the state enterprises).
- 5. Authorization of the Deputy Chairman of the Cabinet of Ministers of Ministers of Turkmenistan supervising corresponding industry for barter operations.
 - 6. Documents confirming an origin of the exported goods:
- If the goods are delivered by the seller to territory of Turkmenistan the contract, the cargo customs declaration;
- If the goods are acquired by the seller in the domestic market the contract, the goods delivery-and-acceptance certificate, the document about payment are submitted according to the repayment terms specified in the contract.
- 7. Accounting of the cost price of manufactured goods if the seller is the manufacturer of the goods.
 - 8. The conformity certificate for shipped goods (from the seller).
- 9. Certificate about availability of the goods signed by the head of the enterprise and by person responsible for materials, sealed by the stamp of the enterprise.
- 10. Documents confirming the right for carrying out of an entrepreneurial activity:

- To legal persons the Charter or Regulations, the statement from Unified State Register of Legal Entities (EGRUL), the registration certificate, the certificate of the participant of foreign trade activities;
- To entrepreneurs without formation of the legal entity the patent and the registration certificate, the certificate of the participant of foreign trade activities.
 - 11. The license for separate kinds of licensed activity.

Notes:

- 1. The approval act of the President of Turkmenistan for import, and export of separate kinds of the goods.
- 2. The Commodity Exchange is entitled to demand additional documents according to requirements of the current legislation of Turkmenistan, as well as depending on contract specifications.
- 3. Contract parties bear responsibility for reliability of documents represented to the Commodity Exchange.

Additional agreement to the contract for commodity exchange (barter)

- 1. Application Letter to the Commodity Exchange with the request for additional agreement registration.
 - 2. Additional agreement not less than three copies (original).
 - 3. Copies of beforehand registered contract and additional agreements.
- 4. Calculation of cost efficiency of the contract for the commodity exchange (barter) confirmed by the head of enterprise.
- 5. The letter of higher authority permitting the conclusion and registration of additional agreement (the state enterprises).
- 6. An origin of the exported goods (in a case of increasing the price or change of the commodity list of the goods);
- If the resident is not the manufacturer (the contract, the cargo customs declaration in a case the goods are acquired in the domestic market the contract, the document about payment and the goods delivery-and-acceptance certificate, copy).
- 7. Accounting of the cost price of manufactured goods if the seller is the manufacturer of the goods.
- 8. The conformity certificate for shipped goods (in a case of increasing of quantity or change of the commodity list of the goods).
- 9. Certificate about availability of the goods signed by the head of the enterprise and by person responsible for materials, sealed by the stamp of the enterprise (in a case of increasing of quantity of the goods).
- 10. Appropriate license for separate types of activity (in a case of increasing of quantity or change of the commodity list of the goods).

Notes:

- 1. Authorization of the Cabinet of Ministers to additional agreement (at change of quantity, the commodity list of the goods and the contract price).
- 2. The Commodity Exchange is entitled to demand additional documents according to requirements of the current legislation of Turkmenistan, as well as depending on contract specifications.
- 3. Contract parties bear responsibility for reliability of documents represented to the Commodity Exchange.
